

OFFICIAL RULES FOR GREAT CLIPS 2011 GRAND GIVEAWAY SWEEPSTAKES

NO PURCHASE NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. THIS SWEEPSTAKES IS VOID WHERE PROHIBITED BY LAW.

Eligibility:

Sweepstakes participants must be at least 18 years of age and a legal resident of the U.S. or Canada to be eligible, except for residents of the province of Quebec where this sweepstakes is void. The Sweepstakes begins 12:01am CST November 14, 2011 and ends 11:59pm CST December 31, 2011 ("Sweepstakes Period").

The Sweepstakes is sponsored by Great Clips, Inc. ("Sponsor").
