

OFFICIAL RULES FOR 2018-19 GREAT CLIPS NEVADA WOLF PACK SWEEPSTAKES

Sweepstakes Period:

The Sweepstakes begins at 12:01 a.m. (CST) December 7, 2018 and ends at 11:30 p.m. (CST) January 18, 2019 (“Sweepstakes Period”).

Eligibility:

Sweepstakes finalists must be U.S. residents at least thirteen (13) years old at time of entry. One (1) sweepstakes winner per household. All employees, officers, directors, agents, members, managers, and owners of Sponsor, the NCAA and its member teams, and each of their respective parents, subsidiaries, affiliates, owners, members, directors, managers, officers, employees, and their advertising agencies, promotional partners, and prize providers or any other company involved with the design, production, execution, or distribution of this Sweepstakes (collectively, the “Sweepstakes Entities” and each a “Sweepstakes Entity”), and any immediate family member (spouse, domestic partner, parents, legal guardians, grandparents, grandchildren, siblings, children, and “step” of each) of a Sweepstakes Entity and any individual living in the same household as a Sweepstakes Entity, high school students and their parents and coaches are not eligible to enter or win.

All entries require a unique sweepstakes code available only from participating Reno Great Clips salons. To enter to win, each eligible entrant must obtain a unique sweepstakes code from a participating Great Clips salon and enter by one or both of the following:

1. Go to www.WinScoreWin.com, enter the sweepstakes code “WOLFPACK” into the code field on the website. Once directed to the website, fill in the required information.
2. Text “WOLFPACK” to “GREAT” (47328) via mobile device. One entry per mobile address. All message and data rates charged are the sole responsibility of the participant. Text STOP to stop. Text HELP for help.

All entries must be received during the Sweepstakes Period. Sponsor is not be responsible for lost, misdirected, late, unsent, incomplete, illegible or unintelligible entries or for inaccurate entry information, whether caused by participant or by any of the equipment or programming associated with or utilized in this entry, or by any technical or human error that may occur in the transmittal of any entry or the processing of any function on the participant's mobile device.
