

OFFICIAL RULES FOR GREAT CLIPS 2018-19
SAN ANTONIO SPURS “GET INTO THE GAME” SWEEPSTAKES

NO PURCHASE NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. THIS SWEEPSTAKES IS VOID WHERE PROHIBITED BY LAW. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING. Sponsor:

Great Clips, Inc. (“Sponsor”) is the sole Sponsor of this sweepstakes. Trademarks and trade names used are for the purposes of prize description only and remain the property of their respective owners who do not endorse Sponsor products and who are not affiliated with the Sweepstakes. The San Antonio Spurs logo and the National Basketball Association (“NBA”) trademarks and copyrights are proprietary to the NBA Entities. All rights reserved.

Sweepstakes Period:

The Sweepstakes begins at 12:01 a.m. (CST) November 16, 2018 and ends at 11:30 p.m. (CST) January 18, 2019 (the “Sweepstakes Period”).

Eligibility:

The San Antonio Spurs “Get Into the Game” Sweepstakes (the “Sweepstakes”) is only open to U.S. residents eighteen (18) years of age or older, living in the State of Texas, with the exception of those living within seventy-five (75) miles of the Dallas, Texas and Houston, Texas city limits. One (1) sweepstakes winner per household. The Sweepstakes is sponsored by Great Clips, Inc. and San Antonio Spurs, L.L.C., a Texas limited liability company d/b/a Spurs Sports & Entertainment (“SSE”) (collectively, the “Sponsors”). All employees, officers, directors and agents and their immediate families or any members of their households, regardless of relationship of the Sponsors, National Basketball Association and its Member Teams, NBA Properties, Inc. and NBA Media Ventures, LLC (collectively, the “NBA Entities”), or any advertising agency or other company involved with the design, production, execution or distribution of this Sweepstakes are not eligible to participate in the program or to win any Prize (defined below). Any Entry (defined below) received from an ineligible participant will be deemed void. By submitting an Entry or accepting a Prize, Entrants accept and agree to be bound by these rules and the decisions of the Sponsors, which shall be final on all matters. Sponsors reserve the right to modify the rules of the Sweepstakes in any way with or without notice at any time, subject to state or federal law.

How To Enter:

All Entries require a unique Sweepstakes code available only from participating Great Clips salons. To enter to win, each eligible Entrant must obtain a unique Sweepstakes code from a participating Great Clips salon and enter by one or both of the following:

1. Go to www.WinScoreWin.com, enter the Sweepstakes code, “SPURS” into the code field on the website. Once directed to the website, fill in the required information. One (1) Entry per household;
2. Text “SPURS” to “GREAT” (47328) via mobile device. One (1) Entry per mobile device. All message and data rates charged are the sole responsibility of the Entrant. Text STOP to stop. Text HELP for help.

All Entries must be received during the Sweepstakes Period. Sponsors are not responsible for lost, misdirected, late, unsent, incomplete, illegible or unintelligible Entries or for inaccurate Entry information,

whether caused by Entrant or by any of the equipment or programming associated with or utilized in this Sweepstakes, or by any technical or human error that may occur in the transmittal of any Entry or the processing of any function on the Entrants mobile device. Entrant must notify Sponsors of any changed mobile device number within the Sweepstakes Period to remain eligible. No purchase is necessary to obtain a Sweepstakes code. There is no cost from the Sponsor for texting an Entry but your cell phone carrier's text-messaging and data rates may apply. Other charges may also apply; check your cell phone plan for details. Sponsors reserve the right, in their sole discretion, to disqualify any individual found to be tampering with the entry process or the operation of the Sweepstakes; to be acting in violation of these rules; or to be acting with intent to annoy, abuse, threaten or harass any other person. Any use of robotic, automatic, programmed or similar entry methods will void all such Entries submitted by such methods. In the event of a dispute as to Entries submitted by multiple users having the same telephone account, the authorized subscriber of the telephone account used to register at the actual time of the Entry will be deemed to be the Entrant and must comply with these rules.

Prize and Selection of Winner:

There will be one (1) winner of the Sweepstakes. Odds of winning are dependent on the number of eligible Entries received. The winner will be entitled to:

- Four (4) game tickets to the San Antonio Spurs vs New Orleans Pelicans game on February 2, 2019;
- Dinner for four (4) at the AT&T Center's SWBC Terrace Club Restaurant;
- One (1) autographed basketball; and
- One (1) \$100 Great Clips gift card

The prize has an Approximate Retail Value (ARV) of one thousand and eighty dollars (\$1,080).

The Winner will be selected from a random drawing on or around January 21, 2019 ("Winner"). Sponsors or their designees will notify the Winner individually by phone, email or text.

The Winner must respond within twenty-four (24) hours of being notified or the Prize may be forfeited and another Entrant chosen. In the event the Winner is under the age of eighteen (18), he/she must be accompanied by a parent or guardian to claim the Prize and are responsible for transportation to and from the AT&T Center. Winner must satisfactorily complete an affidavit of eligibility showing compliance with these rules, and the Winner and any guests accompanying the Winner must also sign a liability and publicity release, allowing Sponsors to use their information for advertising or other purposes. Publicity Release:

Except where prohibited by law, in consideration for being awarded the Prize, Winner hereby agrees and consents, without further authorization, compensation or remuneration of any kind, to the use of Winner's and/or their child's name, likeness, voice, photograph, performance, personal statements, city/state of residence and/or biographical information in any and all advertising, promotions and/or other publicity conducted by Released Parties in any media or format now or hereafter known without further compensation, permission or notification.

Limitation of Liability and Dispute Resolution:

Except where prohibited, each Entrant and the Winner accepting the Prize agree that: (a) all issues and questions concerning these rules shall be governed by Texas law without giving effect to any principles of conflicts of law of any jurisdiction; (b) any and all disputes, claims and causes of action at law or in equity arising out of or relating to this Sweepstakes or any Prize awarded shall be (i) resolved individually, without resort to any form of class action; and (ii) filed only in the state courts situated in Texas, and Entrant hereby consents and submits to the personal jurisdiction of such courts for the purposes of litigating any such disputes, claims or causes of action; (c) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, but in no event attorneys' fees; and (d) under no circumstances will any Entrant be permitted to obtain awards for and hereby waives all rights to claim punitive, incidental, special, consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased and (e) Sponsors and San Antonio Spurs, L.L.C. are not responsible or liable for any loss, damage, inconvenience, or loss of time arising out of any acts, omissions, or negligence, of any person including, without limitation, air and ground transportation carriers, the game venue, the players participating in the game, and any person providing any service or accommodation in conjunction with the Prize, or for delays or cancellations including, but not limited to, those resulting from mechanical breakdown, closings, strikes, government action, inclement weather, sickness, injury, Acts of God, an act of terrorism, or a civil disturbance. The Winner and Guest agree to abide by all rules and policies of the game venue and are subject to removal for non-compliance or unruly behavior. Winner agrees to release, discharge, indemnify, and hold harmless the Sponsor, San Antonio Spurs, L.L.C. and their respective parent companies and affiliates and directors, officers, employees, and agents, from any claims due to any injuries, damages or losses incurred by the Winner, or caused by the Winner, (including death) resulting in whole or in part from attendance at the game, use of the Prize, or participation in the Sweepstakes.
