

## **OFFICIAL RULES FOR GREAT CLIPS 2018 CHICAGO BEARS AWAY GAME SWEEPSTAKES**

All rights reserved. All entries must be received during the Sweepstakes Period. Sponsor is not be responsible for lost, misdirected, late, unsent, incomplete, illegible or unintelligible entries or for inaccurate entry information, whether caused by participant or by any of the equipment or programming associated with or utilized in this entry, or by any technical or human error that may occur in the transmittal of any entry or the processing of any function on the participant's mobile device. **Prizes and Selection of Winners:**

There is one (1) Grand Prize Sweepstakes prize winner as follows:
