

# OFFICIAL RULES FOR GREAT CLIPS 2018 DETROIT RED WINGS SWEEPSTAKES

**NO PURCHASE NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. THIS SWEEPSTAKES IS VOID WHERE PROHIBITED BY LAW. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING. ## **Sponsor:**

## **Sweepstakes Period:**

The Sweepstakes begins 12:00 a.m. EST November 23rd, 2018 and ends 11:59 p.m. EST January 25th, 2019 ("Sweepstakes Period").

## **Eligibility:**

Sweepstakes entrants must be U.S. residents over eighteen (18) years old at time of entry and live within seventy-five (75) miles of the Detroit, MI corporate limits. One (1) sweepstakes winner per household. All employees, officers, directors, agents, members, managers, and owners of Sponsor, the NHL and its member teams, NHL Properties, Inc., and each of their respective parents, subsidiaries, affiliates, owners, members, directors, managers, officers, employees, and their advertising agencies, promotional partners, and prize providers or any other company involved with the design, production, execution, or distribution of this Sweepstakes (collectively, the "Sweepstakes Entities" and each a "Sweepstakes Entity"), and any immediate family member (spouse, domestic partner, parents, legal guardians, grandparents, grandchildren, siblings, children, and "step" of each) of a Sweepstakes Entity and any individual living in the same household as a Sweepstakes Entity are not eligible to enter or win.

Any entry received from an ineligible participant will be deemed void. ## **How To Enter:**

All entries require a unique sweepstakes code available only from participating Great Clips salons. To enter to win, each eligible entrant must obtain a unique sweepstakes code from a participating Great Clips salon. - Go to [www.WinScoreWin.com](http://www.WinScoreWin.com), enter the sweepstakes code "REDWINGS" into the code field on the website. Once directed to the website, fill in the required information. Limit one (1) entry per internet protocol (IP) address.

Or use the alternate mode of entry by texting as directed below:

- Text "REDWINGS" to "GREAT" (47328) via mobile device. One (1) entry per mobile address. All message and data rates charged are the sole responsibility of the participant. Text STOP to stop. Text HELP for help.

All entries must be received during the Sweepstakes Period. Sponsor is not be responsible for lost, misdirected, late, unsent, incomplete, illegible or unintelligible entries or for inaccurate entry information, whether caused by participant or by any of the equipment or programming associated with or utilized in this entry, or by any technical or human error that may occur in the transmittal of any entry or the processing of any function on the participant's mobile device. Entrants must notify Sponsor of any changed mobile device number within the Sweepstakes Period to remain eligible. No purchase is necessary to obtain a sweepstakes code. Sponsor reserves the right, in its sole discretion, to disqualify any individual found to be tampering with the entry process or the operation of the entry; to be acting in violation of these rules; or to be acting with intent to annoy, abuse, threaten or harass any other person. Any use of robotic, automatic, programmed or similar entry methods will void all such entries submitted by such methods. In the event of a dispute as to entries submitted by multiple users having the same telephone account, the authorized subscriber of the telephone account used to register at the actual time of the entry will be deemed to be the entrant and must comply with these rules.

**Prizes and Selection of Winner:**

There are six (6) prizes awarded to winners of the Sweepstakes. Odds of winning are dependent on the number of eligible entries received. The winner will be entitled to:

Winner and Guest agree to abide by all rules and policies of the game venue and are subject to removal for non-compliance or unruly behavior. Winner agrees to release, discharge, indemnify, and hold harmless the Sponsor, Detroit Red Wings and their respective parent companies and affiliates and directors, officers, employees, and agents, from any claims due to any injuries, damages or losses incurred by the Winner, or caused by the Winner, (including death) resulting in whole or in part from attendance at the game, use of the Prize, or participation in the Sweepstakes.
