

OFFICIAL RULES FOR GREAT CLIPS GREAT SEATS 2018 FORT WAYNE KOMETS SWEEPSTAKES

NO PURCHASE NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. THIS SWEEPSTAKES IS VOID WHERE PROHIBITED BY LAW. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING. Sponsor:

Great Clips, Inc. (“Sponsor”) is the sole Sponsor of this sweepstakes. Trademarks and trade names used are for the purposes of prize description only and remain the property of their respective owners who do not endorse Sponsor products and who are not affiliated with the Sweepstakes. The Fort Wayne Komets logo and the East Coast Hockey League (“ECHL”) trademarks and copyrights are proprietary to the ECHL Entities. All rights reserved.

Sweepstakes Period:

The Sweepstakes begins at 12:01 a.m. October 5th, 2018 and ends at 11:59 p.m. December 28th, 2018. (the “Sweepstakes Period”).

Eligibility:

Sweepstakes finalists must be U.S. residents at least thirteen (13) years of age at time of entry. One (1) sweepstakes winner per household. All employees, officers, directors, agents, members, managers, and owners of Sponsor, the ECHL and its member teams, and each of their respective parents, subsidiaries, affiliates, owners, members, directors, managers, officers, employees, and their advertising agencies, promotional partners, and prize providers or any other company involved with the design, production, execution, or distribution of this Sweepstakes (collectively, the “Sweepstakes Entities” and each a “Sweepstakes Entity”), and any immediate family member (spouse, domestic partner, parents, legal guardians, grandparents, grandchildren, siblings, children, and “step” of each) of a Sweepstakes Entity and any individual living in the same household as a Sweepstakes Entity are not eligible to enter or win.

Any entry received from an ineligible participant will be deemed void. By submitting an entry or accepting a prize, participants accept and agree to be bound by these rules and the decisions of the Sponsor, which shall be final on all matters. Sponsor reserves the right to modify the rules of the Sweepstakes in any way at any time, subject to state or federal law.

How To Enter:

All entries require a unique sweepstakes code available only from participating Great Clips salons. To enter to win, each eligible entrant must obtain a unique sweepstakes code from a participating Great Clips salon and enter by one or both of the following:

1. Go to www.WinScoreWin.com, enter the sweepstakes code “KOMETS18” into the code field on the website. Once directed to the website, fill in the required information.
2. Text “KOMETS18” to “GREAT” (47328) via mobile device. One entry per mobile address. All message and data rates charged are the sole responsibility of the participant. Text STOP to stop. Text HELP for help.

All entries must be received during the Sweepstakes Period. Sponsor is not be responsible for lost, misdirected, late, unsent, incomplete, illegible or unintelligible entries or for inaccurate entry information, whether caused by participant or by any of the equipment or programming associated with or utilized in this entry, or by any technical or human error that may occur in the transmittal of any entry or the processing of any function on the participant's mobile device. Entrants must notify Sponsor of any changed mobile device number within the Sweepstakes Period to remain eligible. No purchase is necessary to obtain a sweepstakes code. There is no cost from the Sponsor for texting an entry but your cell phone carrier's text-messaging and data rates may apply. Other charges may also apply; check your cell phone plan for details. Sponsor reserves the right, in its sole discretion, to disqualify any individual found to be tampering with the entry process or the operation of the entry; to be acting in violation of these rules; or to be acting with intent to annoy, abuse, threaten or harass any other person. Any use of robotic, automatic, programmed or similar entry methods will void all such entries submitted by such methods. In the event of a dispute as to entries submitted by multiple users having the same telephone account, the authorized subscriber of the telephone account used to register at the actual time of the entry will be deemed to be the entrant and must comply with these rules.

Prizes and Selection of Winner:

There will be one (1) winner of the Sweepstakes for every home game for the 2018-19 regular season. Odds of winning are dependent on the number of eligible entries received. Each winner will be entitled to:

- Four (4) game vouchers good for a predetermined regular season Komets home game
- Opportunity to sit in the penalty box during warm ups
- Prize package from the Komets and Great Clips

Approximate Retail Value of the Prize is \$100.

Prizes cannot be redeemed for cash. No substitution of prizes is permitted. Prizes are not transferable. Only one sweepstakes winner per household. Winners will be selected from random drawings through January 2, 2019. Fort Wayne Komets or designee will notify each winner individually by phone, email or text. Winners must respond twenty-four (24) hours of being notified or the prize may be forfeited and another entrant chosen. Prize recipients under the age of eighteen (18) must be accompanied by a parent or guardian to claim their prize and are responsible for transportation to and from Allen County War Memorial Coliseum. Each winner must satisfactorily complete an affidavit of eligibility showing compliance with this rules, and each winner and any guests accompanying winner must also sign a liability and publicity release, allowing Sponsor to use their information for advertising or other purposes. Failure to complete these forms may result in forfeiture of the prize. In the event that the potential winner is disqualified for any reason, the Sponsor may select an alternate potential winner by random drawing from among all remaining eligible entries.

Publicity Release:

Entrants and winners agree that the Sponsor and designees may use entrant's name, voice, city/state of residence, photograph and/or likeness of the winner and their child for advertising and/or trade and/or for any other purpose in any media or format now or hereafter known without further compensation, permission or notification.

Limitation of Liability and Dispute Resolution:

Except where prohibited, each entrant and winner accepting a prize agrees that: (a) all issues and questions concerning these rules shall be governed by Minnesota law without giving effect to any principles of conflicts of law of any jurisdiction; (b) any and all disputes, claims and causes of action at law or in equity arising out of or relating to this program or any prize awarded shall be (i) resolved individually, without resort to any form of class action; and (ii) filed only in the state courts situated in Minnesota, and entrant hereby consents and submits to the personal jurisdiction of such courts for the purposes of litigating any such disputes, claims or causes of action; (c) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, but in no event attorneys' fees; and (d) under no circumstances will any entrant be permitted to obtain awards for and hereby waives all rights to claim punitive, incidental, special, consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased and (e) Sponsor and Fort Wayne Komets are not responsible or liable for any loss, damage, inconvenience, or loss of time arising out of any acts, omissions, or negligence, of any person including, without limitation, air and ground transportation carriers, the game venue, the players participating in the game, and any person providing any service or accommodation in conjunction with the Prize, or for delays or cancellations including, but not limited to, those resulting from mechanical breakdown, closings, strikes, government action, inclement weather, sickness, injury, Acts of God, an act of terrorism, or a civil disturbance. Winner and Guest agree to abide by all rules and policies of the game venue and are subject to removal for non-compliance or unruly behavior.
