

## **OFFICIAL RULES FOR 2018 GREAT CLIPS NC STATE WOLFPACK BASKETBALL GREAT SEATS SWEEPSTAKES**

### **Sweepstakes Period:**

The Sweepstakes begins at 12:01 a.m. (CST) November 16, 2018, and ends at 11:30 p.m. (CST) December 21, 2018 (the "Sweepstakes Period").

### **Eligibility:**

Sweepstakes finalists must be U.S. residents at least thirteen (13) years old at time of entry and have primary residence in North Carolina, South Carolina or Virginia. One (1) sweepstakes winner per household. All employees, officers, directors, agents, members, managers, and owners of Sponsor, the NCAA and its member teams, NCAA Properties, Inc., and each of their respective parents, subsidiaries, affiliates, owners, members, directors, managers, officers, employees, and their advertising agencies, promotional partners, and prize providers or any other company involved with the design, production, execution, or distribution of this Sweepstakes (collectively, the "Sweepstakes Entities" and each a "Sweepstakes Entity"), and any immediate family member (spouse, domestic partner, parents, legal guardians, grandparents, grandchildren, siblings, children, and "step" of each) of a Sweepstakes Entity and any individual living in the same household as a Sweepstakes Entity are not eligible to enter or win.

Sponsor is not be responsible for lost, misdirected, late, unsent, incomplete, illegible or unintelligible entries or for inaccurate entry information, whether caused by participant or by any of the equipment or programming associated with or utilized in this entry, or by any technical or human error that may occur in the transmittal of any entry or the processing of any function on the participant's mobile device. Entrants must notify Sponsor of any changed mobile device number within the Sweepstakes Period to remain eligible. No purchase is necessary to obtain a sweepstakes code.
