

**OFFICIAL RULES FOR GREAT CLIPS  
2018 BUCKEYE KIDS CAPTAIN SWEEPSTAKES**

**NO PURCHASE NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. THIS SWEEPSTAKES IS VOID WHERE PROHIBITED BY LAW. **Sponsor:**

Great Clips, Inc. is the sole Sponsor of this sweepstakes. Trademarks and trade names used are for the purposes of prize description only and remain the property of their respective owners who do not endorse Sponsor products and who are not affiliated with the Sweepstakes. The Ohio State Buckeyes (“OSU”) logo and the National Collegiate Athletic Association (“NCAA”) trademarks and copyrights are proprietary to the NCAA Entities. All rights reserved.

**Sweepstakes Period:**

The Sweepstakes begins at 12:01 a.m. (CST) September 21st, 2018 and ends at 11:59 p.m. (CST) December 14th, 2018 (the “Sweepstakes Period”).

**Eligibility:**

Sweepstakes entrants must be U.S. residents over eighteen (18) and the legal parent or guardian of a child between the ages of eight (8) and thirteen (13) at time of entry. One (1) sweepstakes winner per household. All employees, officers, directors, agents, members, managers, and owners of Sponsor, the NCAA and its member teams, NCAA Properties, Inc., and each of their respective parents, subsidiaries, affiliates, owners, members, directors, managers, officers, employees, and their advertising agencies, promotional partners, and prize providers or any other company involved with the design, production, execution, or distribution of this Sweepstakes (collectively, the “Sweepstakes Entities” and each a “Sweepstakes Entity”), and any immediate family member (spouse, domestic partner, parents, legal guardians, grandparents, grandchildren, siblings, children, and “step” of each) of a Sweepstakes Entity and any individual living in the same household as a Sweepstakes Entity are not eligible to enter or win.

Any entry received from an ineligible participant will be deemed void. By submitting an entry or accepting a prize, participants accept and agree to be bound by these rules and the decisions of the Sponsor, which shall be final on all matters. Sponsor reserves the right to modify the rules of the Sweepstakes in any way at any time, subject to state or federal law.

**How To Enter:**

All entries require a unique sweepstakes code available only from participating Great Clips salons. To enter to win, each eligible entrant must obtain a unique sweepstakes code from a participating Great Clips salon and enter by one or both of the following:

1. Text “BUCKEYES” to “GREAT” (47328) via mobile device. One entry per mobile address. Limit one (1) keyword entry per mobile address. Message and data rates may apply. Text STOP to stop. Text HELP for help.
2. Go to [www.WinScoreWin.com](http://www.WinScoreWin.com), enter the sweepstakes code “BUCKEYES” into the code field on the website. Once directed to the website, fill in the required information.

All entries must be received during the Sweepstakes Period. Sponsor is not responsible for lost, misdirected, late, unsent, incomplete, illegible or unintelligible entries or for inaccurate entry information, whether caused by participant or by any of the equipment or programming associated with or utilized in this entry, or by any technical or human error that may occur in the transmittal of any entry or the processing of any function on the participant's mobile device. Participant must notify sponsors of any changed mobile device number within the Sweepstakes Period to remain eligible. No purchase is necessary to obtain a sweepstakes code. There is no cost from the Sponsor for texting an entry but your cell phone carrier's text-messaging and data rates may apply. Other charges may also apply; check your cell phone plan for details. Sponsor reserves the right and sole discretion, to disqualify any individual found to be tampering with the entry process or the operation of the entry; to be acting in violation of these rules; or to be acting with intent to annoy, abuse, threaten or harass any other person. Any use of robotic, automatic, programmed or similar entry methods will void all such entries submitted by such methods. In the event of a dispute as to entries submitted by multiple users having the same telephone account, the authorized subscriber of the telephone account used to register at the actual time of the entry will be deemed to be the participant and must comply with these rules.

**Prizes and Selection of Winner:**

There will be one (1) "Great Clips Buckeye Kids Captain" prize recipient for each of sixteen (16) OSU Men's Hockey home games, each of twenty-one (21) OSU Men's Basketball home games, and each of nineteen (19) Women's Basketball home games. Each "Great Clips Buckeye Kid Captain" prize recipient will receive:

- Two (2) home game tickets
- Two (2) Ohio State T-shirts
- Opportunity to watch warm-ups from courtside or rinkside
- Pre-game acknowledgement on scoreboard and recognition during halftime/intermission.
- VIP arena tour

Approximate Retail Value for Men's Basketball is \$100; for Women's Basketball and Men's Hockey is \$75

Prizes cannot be redeemed for cash. No substitution of prizes is permitted. Prizes are not transferable. Only one sweepstakes winner per household. Winners will be selected in random drawings on December 17th, 2018. OSU or designee will notify each winner individually by phone, email, text message, or mail and will receive instructions from Ohio State Sports Marketing.

Each winner must respond within five days of being notified or the prize may be forfeited and another entrant chosen. Prize recipients must provide their own transportation to and from the designated venue and comply with instructions for claiming prizes. Prize recipients must be accompanied by their eligible child when awarded the prize. Each winner must satisfactorily complete an affidavit of eligibility showing compliance with this rules, and each winner and any guests accompanying winner must also sign a liability and publicity release, allowing Sponsor to use their information for advertising or other purposes. Failure to complete these forms may result in forfeiture of the prize. In the event that the potential winner is disqualified for any reason, the Sponsor may select an alternate potential winner by random drawing from among all remaining eligible entries.

Winners are solely responsible for all applicable federal, state or provincial, and local taxes and any expenses associated with any prizes. **Limitation of Liability and Dispute Resolution**

Except where prohibited, each entrant and child accepting a prize agrees that: (a) all issues and questions concerning these rules shall be governed by Minnesota law without giving effect to any principles of conflicts of law of any jurisdiction; (b) any and all disputes, claims and causes of action at law or in equity arising out of or relating to this program or any prize awarded shall be (i) resolved individually, without resort to any form of class action; and (ii) filed only in the state courts situated in Minnesota, and entrant hereby consents and submits to the personal jurisdiction of such courts for the purposes of litigating any such disputes, claims or causes of action; (c) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, but in no event attorneys' fees; and (d) under no circumstances will any entrant be permitted to obtain awards for and hereby waives all rights to claim punitive, incidental, special, consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased and (e) Sponsor and OSU are not responsible or liable for any loss, damage, inconvenience, or loss of time arising out of any acts, omissions, or negligence, of any person including, without limitation, air and ground transportation carriers, the game venue, the players participating in the game, and any person providing any service or accommodation in conjunction with the Prize, or for delays or cancellations including, but not limited to, those resulting from mechanical breakdown, closings, strikes, government action, inclement weather, sickness, injury, Acts of God, an act of terrorism, or a civil disturbance. Winner and Guest agree to abide by all rules and policies of the game venue and are subject to removal for non-compliance or unruly behavior. Winner agrees to release, discharge, indemnify, and hold harmless the Sponsor, OSU and their respective parent companies and affiliates and directors, officers, employees, and agents, from any claims due to any injuries, damages or losses incurred by the Winner, or caused by the Winner, (including death) resulting in whole or in part from attendance at the game, use of the Prize, or participation in the Sweepstakes.
