

OFFICIAL RULES FOR 2018 GREAT CLIPS SACRAMENTO KINGS VIP EXPERIENCE SWEEPSTAKES

Sponsor:

The Sacramento Kings logo and the National Basketball Association (the "NBA") trademarks and copyrights are proprietary to the NBA Entities. All rights reserved.

Sweepstakes Period:

The Sweepstakes begins at 12:01 a.m. (PDT) November 16, 2018, and ends at 11:30 p.m. (PDT) February 15, 2019 (the "Sweepstakes Period").

Eligibility:

Sweepstakes finalists must be U.S. residents at least eighteen (18) years old at time of entry, who are legal residents of California and whose primary residence is within a seventy-five (75) mile radius of 500 David J Stern Walk, Sacramento, California (the "Sweepstakes Area"). One (1) sweepstakes winner per household.

2. Text "KINGS" to "GREAT" (47328) via mobile device. One Entry per mobile device. All message and data rates charged are the sole responsibility of the Entrant. Text STOP to stop. Text HELP for help.

One entry per person. Any additional entries will be deemed void. All entries must be received during the Sweepstakes Period. Sponsor is not be responsible for lost, misdirected, late, unsent, incomplete, illegible

or unintelligible entries or for inaccurate entry information, whether caused by participant or by any of the equipment or programming associated with or utilized in this entry, or by any technical or human error that may occur in the transmittal of any entry or the processing of any function on the participant's mobile device. Entrants must notify Sponsor of any changed mobile device number within the Sweepstakes Period to remain eligible. No purchase is necessary to obtain a sweepstakes code. Date and time of Sacramento Kings regular season home game shall be determined or changed by Prize Provider in its sole discretion. No substitution of prizes is permitted. Prizes are not transferable. Only one (1) sweepstakes winner per household.

Winners must respond within twenty-four (24) hours of being notified or the prize may be forfeited and another entrant chosen. Each winner must satisfactorily complete an affidavit of eligibility showing compliance with these rules, and each winner and any guests accompanying winner must also sign a liability and publicity release, allowing Sponsor Prize Provider to use their information, and the NBA for advertising or other purposes.
