

OFFICIAL RULES FOR 2018 GREAT CLIPS UNC-TAR HEELS GREAT SEATS SWEEPSTAKES

Sponsor:

Sweepstakes Period:

The Sweepstakes begins at 12:01 a.m. (CST) November 16, 2018, and ends at 11:30 p.m. (CST) December 21, 2018 (the “Sweepstakes Period”).

Eligibility:

Sweepstakes finalists must be U.S. residents at least thirteen (13) years old at time of entry and have primary residence in North Carolina, South Carolina or Virginia. One (1) sweepstakes winner per household. All employees, officers, directors, agents, members, managers, and owners of Sponsor, the NCAA and its member teams, NCAA Properties, Inc., Tar Heels Sports Properties, LLC and each of their respective parents, subsidiaries, affiliates, owners, members, directors, managers, officers, employees, and their advertising agencies, promotional partners, and prize providers or any other company involved with the design, production, execution, or distribution of this Sweepstakes (collectively, the “Sweepstakes Entities” and each a “Sweepstakes Entity”), and any immediate family member (spouse, domestic partner, parents, legal guardians, grandparents, grandchildren, siblings, children, and “step” of each) of a Sweepstakes Entity and any individual living in the same household as a Sweepstakes Entity are not eligible to enter or win. 1. Go to www.WinScoreWin.com, enter the sweepstakes code “TARHEELS” into the code field on the website. Once directed to the website, fill in the required information.

2. Text "TARHEELS" to "GREAT" (47328) via mobile device. One entry per mobile address. All message and data rates charged are the sole responsibility of the participant. Text STOP to stop. Text HELP for help.

All entries must be received during the Sweepstakes Period.
