

OFFICIAL RULES FOR GREAT CLIPS 2018 WASHINGTON HUSKIES GREAT SEATS SWEEPSTAKES

NO PURCHASE NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. THIS SWEEPSTAKES IS VOID WHERE PROHIBITED BY LAW. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING. Sponsor:

Great Clips, Inc. (“Sponsor”) is the sole Sponsor of this sweepstakes. Sweepstakes Period:

The Sweepstakes begins at 12:01 a.m. (CST) November 23rd, 2018 and ends at 11:30 p.m. (CST) February 15th, 2019 (the “Sweepstakes Period”).

Eligibility:

Sweepstakes finalists must be U.S. residents at least thirteen (13) years old at time of entry and have primary residence in Idaho, Oregon or Washington. One (1) sweepstakes winner per household. All employees, officers, directors, agents, members, managers, and owners of Sponsor, University of Washington Intercollegiate Athletics, the NCAA and its member teams, NCAA Properties, Inc., and each of their respective parents, subsidiaries, affiliates, owners, members, directors, managers, officers, employees, and their advertising agencies, promotional partners, and prize providers or any other company involved with the design, production, execution, or distribution of this Sweepstakes (collectively, the “Sweepstakes Entities” and each a “Sweepstakes Entity”), and any immediate family member (spouse, domestic partner, parents, legal guardians, grandparents, grandchildren, siblings, children, and “step” of each) of a Sweepstakes Entity and any individual living in the same household as a Sweepstakes Entity are not eligible to enter or win.

Any entry received from an ineligible participant will be deemed void. How To Enter:

All entries require a unique sweepstakes code available only from participating Great Clips salons. To enter to win, each eligible entrant must obtain a unique sweepstakes code from a participating Great Clips salon and enter by one or both of the following:

1. Go to www.WinScoreWin.com, enter the sweepstakes code “GOHUSKIES” into the code field on the website. Once directed to the website, fill in the required information.

2. Text "GOHUSKIES" to "GREAT" (47328) via mobile device. One entry per mobile address. All message and data rates charged are the sole responsibility of the participant. Text STOP to stop. Text HELP for help.

All entries must be received during the Sweepstakes Period. Sponsor is not be responsible for lost, misdirected, late, unsent, incomplete, illegible or unintelligible entries or for inaccurate entry information, whether caused by participant or by any of the equipment or programming associated with or utilized in this entry, or by any technical or human error that may occur in the transmittal of any entry or the processing of any function on the participant's mobile device. Entrants must notify Sponsor of any changed mobile device number within the Sweepstakes Period to remain eligible. No purchase is necessary to obtain a sweepstakes code. Sponsor reserves the right, in its sole discretion, to disqualify any individual found to be tampering with the entry process or the operation of the entry; to be acting in violation of these rules; or to be acting with intent to annoy, abuse, threaten or harass any other person. Any use of robotic, automatic, programmed or similar entry methods will void all such entries submitted by such methods. In the event of a dispute as to entries submitted by multiple users having the same telephone account, the authorized subscriber of the telephone account used to register at the actual time of the entry will be deemed to be the entrant and must comply with these rules.

Prizes and Selection of Winner:

There will be one (1) sweepstakes winner. Odds of winning are dependent on the number of eligible entries received. Each winner will be entitled to:

- \$100 Great Clips gift card

Each prize has an Approximate Retail Value (ARV) of two-hundred dollars (\$200).

Winners will be selected from random drawings on or about February 18, 2019. Winners will be notified by phone, email or text. The Winner must respond within 24 hours of being notified or the prize may be forfeited and another entrant chosen.
